- On-site symposium signage near on-site registration.

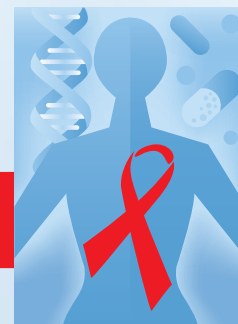
Fees DO NOT Include:
